

CONDITIONS OF HIRE

Please read the conditions of hire and sign.

1. We are open 7 days a week. (Sunday 8am - 10am)
2. Payment is strictly in advance when booking the items hired.
3. A deposit is payable, which is fully refundable, if the following conditions are met:
 - Please return your equipment in the same condition as you received it. Cleaned and packed.
 - DIRTY, WET & MUDDY EQUIPMENT will result in the loss of deposit and additional cleaning charges.
 - A R500 drying and cleaning fee will be levied if returned wet.
 - Late returns will result in loss of deposit and additional hiring fees.
4. Please do not leave or use the equipment in the rain, pack it up after use, store under shelter and return on time.
5. No eating, drinking, sharp objects or shoes are allowed on the equipment.
6. No person over the age of 12 years allowed on equipment unless otherwise stated, that is, adults on ADULT JUMPING CASTLES AND SLIDES only.
7. Please do not allow children to sit, climb or hang on the side walls.
8. In the event of a cancellation due to inclement weather, a rain date voucher is given. No cash refunds.
9. There is no refund on cancellations 5 days prior to the rental date.
10. Use of equipment is entirely at lessee's own risk and must at all times be under adult supervision.
11. Only foam bath OR child friendly products are to be used on splash and water slides.
12. A suitable area for equipment, free of stones, other sharp objects, any obstacles, fires (braais) and debris is required. The item should be on grass and in the shade.
13. No persons are to play with or around the motor.
14. Water fittings, pegs and extension cables are not included.
15. TONY MILLER PROMOTIONS has these items for hire, see 'Hardware and deposits' below.
16. Use only 12 gauge 15 amp rated cables not exceeding 20m in length.
17. DO NOT RUN THE BLOWER WITHOUT THE CASTLE INLET PIPE SECURED ONTO IT.
18. For popcorn machines, candy floss machines, sky dancers and helium, please follow operating and cleaning instructions given.
19. Client is to check that the equipment is connected to an earthed power supply.
20. Sumo Wrestling Suits must not be used in conjunction with

water or in the rain.

21. We reserve the right to substitute jumping castle when it deems necessary.
22. Wind: For your own safety, Castles must be deflated during strong winds.

Hardware and deposits

- Suitable extension cords are available for hire.
- Heavy duty pegs are required for jumping castles. Pegs are available at R100 refundable deposit on return.
- The refundable security deposit is R300.00 per item hired.

Overnight rentals

- In the case of overnight rentals all equipment must be secured in a gated and burglar guarded location. The safety of equipment must be guaranteed.

Power Outages / Load Shedding

Please check the schedule for load shedding. Generators are available for hire from TONY MILLER PROMOTIONS.

Compensation

The lessee agrees to compensate TONY MILLER PROMOTIONS for the following should they arise.

- a. Cost of repair/replacement of equipment due to loss or damage caused intentionally, recklessly, and/or negligently whilst the equipment is under the hire to the lessee (e.g. knife wounds, torn stitching and material due to adults on the equipment etc.).
- b. Cost of replacement of lost or stolen equipment whilst equipment is hired to the lessee.
- c. Loss of income incurred whilst the equipment is under repair or being replaced, as a result of damages or loss caused in terms of (a) or (b) above.
- d. Cost incurred legal or otherwise, in the pursuance of any claim, however arising, which TONY MILLER PROMOTIONS may have against the lessee.

Delivery

- In the case of delivery, all equipment will be delivered to an accessible, flat, level and cleaned area.
- Heavier items will require drive in access to point of set-up.
- We do not go through doorways, through houses, up or down embankments and stairways.
- Delivery and removal services are provided by sub-contractors at an additional fee.
- Set-up is at the discretion of the contractor.

Lessee agrees to -

- Grant TONY MILLER PROMOTIONS access with or without the assistance of The South African Polices Services or duly appointed Security Services provider to recover any equipment not returned.
- Pay all legal fees for the recovery of monies due for any losses and/or damages.
- All legal action will be in the Durban magisterial area.
- TONY MILLER PROMOTIONS, its owners and/or employees/sub-contractors, do not accept responsibility and/or liability for any injuries, deaths. Losses or damaged caused directly or indirectly to any person and/or property whilst the equipment is in the use or under hire to the lessee.
- Payment of the rental fee indicates acceptance of the terms and conditions stipulated herein.
- Please note that signing for the above mentioned Conditions for Hire, means that you have read and understood the above mentioned conditions of hire.
